



MADE TO ORDER “MTO” PROGRAM

Some profiles and lengths are only available as “Made To Order” (MTO) and will only be produced as can be reasonably accommodated. Typical requirements for MTO requests are listed below but are subject to change. All MTO requests are subject to a credit review, Customer Service approval, and Production acceptance.

MTO Classification

- I. **Special Lengths:**
Requires a 12 bundle minimum of one profile, one color, and only one length.
No stock. Must be authorized for shipment upon completion or will be invoiced. Twice yearly max.
- II. **Proprietary and Exclusivity Profiles:**
By special arrangement and typically run no more than once or twice a year.
Dependent upon volume orders. Must ship within 30 days of completion or will be invoiced. No stock.
- III. **Special and Low Volume Profiles:**
Typically run once or twice a year.
Standard lengths and colors only.
No special lengths.

Contact your Homeland representative for information on the MTO program. MTO item requests must be submitted in writing via e-mail or fax. Not all requests can be accommodated. Customer Account must be in good standing and current before MTO requests will be considered. MTO requests are not accepted until approved and confirmed in writing. Cash in Advance customers may be required to make payment at time of order acceptance. Once confirmed, the order cannot be canceled by customer. Orders must ship complete once ready, leaving no back-orders. Lead-times for MTO items cannot be estimated until requests have been approved and confirmed. MTO items may only be produced a very limited number of times per year. Please plan ahead and make any MTO requests as early as possible to take advantage of each production run on MTO profiles. Due to the infrequent running of MTO items, and depending on the item, it may be a number of weeks before an answer can be given on an MTO request. Minimum purchase quantity required of the same profile and color for all MTO items. Requirements may vary by profile. Homeland will try to accommodate reasonable requests, but MTO orders will ship and be invoiced shortly after completion. Except as otherwise noted here, Homeland's Terms and Conditions apply to all MTO requests accepted as orders. Details and requirements of this program are subject to change without notice. Consult your Homeland representative for additional details.

HOMELAND FENCE BEST PRACTICES

Homeland offers 4 levels of Fence Colors:

WHITE

LIGHT: Tan, Light Gray

MEDIUM: Sand, Adobe, Aspen Latte, Gray

DARK: Dark Gray, Chai Gray, Ash Gray, Green Teak, Mocha Walnut

These guidelines are for all levels of fence colors, with additional guidelines added for Medium and Dark colors at the end.

Prior to installation, download and review Homeland Vinyl Products (HVP) Privacy and Gate Installation at: <http://homelandvinyl.com/resources/documents/>

All levels of color:

1. Avoid heat sources:
 - Do not use any clear wrapping or shrink wrap during storage or transportation. Make sure any wrap or protection of the profiles does not absorb and retain heat. It will cause warping.
 - Do not store or install product next to a heat source.
 - Avoid installing the product near reflective surfaces (e.g. glass windows and glass doors), which can concentrate sunlight and heat the product.
 - Avoid installing the product on or adjacent to materials that can radiate absorbed heat such as concrete, asphalt, or dark-colored gravel.
2. Make sure all metal stiffeners are in the correct orientation for the rail as used.
3. Make sure all rails are notched, pinned or plated.
4. U-channel trim must be secured with 3 screws to the post to help stabilize T&G boards. Please refer to the Privacy Fence Installation Guide for placement (Image C).
5. Product expansion and contraction is temperature dependent and will be more prominent in longer lengths and darker colors. Please take this into account during installation.
 - Make sure rail ends have at least 1 inch clearance of each other when inserted into posts for 6' spans, and at least 1.5 inch

Homeland Vinyl Products does not warranty bowing of pickets. Please make sure of proper installation to reduce all of the factors mentioned.

clearance on 8 foot spans. This will allow for adequate expansion and contraction of rails within the posts and prevent bowing.

- Make sure pickets are cut for adequate clearance within the rail pocket to allow for thermal expansion. If the pickets are binding against the rail, they will cause excessive bowing with thermal expansion.
- When dealing with installation on slopes, ensure that there is adequate clearance for pickets inside of the rail and cut picket at a slight angle if necessary.

6. Do not put dirt or mulch against rails. It could cause rails to permanently bow out.

In addition to guidelines 1-9, please consider the following information regarding HVP Medium and Dark colored products:

Medium Colors:

7. For horizontal privacy pannel installations, HVP approved metal picket stiffeners must be used to reduce T&G bowing. HVP approved metal stiffeners must be used in bottom rails.

Dark Colors:

8. Scratches will be more evident in darker colors. Use caution when transporting and installing the products.

9. HVP approved metal stiffeners must be used in all rails.

- For vertical privacy pannel installations, mid-rail or HVP approved metal picket stiffeners must be used to reduce T&G bowing.

- For horizontal privacy pannel installations, HVP approved metal picket stiffeners must be used to reduce T&G bowing. (Image D).


10. HVP does not recommend installing horizontal privacy pannel sections wider than 6' on center.

Homeland Vinyl Products does not warranty bowing of pickets or sagging rails. Please make sure of proper installation to reduce all of the factors mentioned.



A. 5-1/2", 7" and 8" Nexus or Gorilla Pocket Rail & Mid-Rail




B. Vertical Fence - Top Down View 6' Span 8' Span

D. Horizontal Fence



TERMS AND CONDITIONS

TERMS OF PAYMENT – Terms of payment are set forth on the invoice. If no payment terms are listed on the invoice, then the default terms of payment are payment in full at time of shipment. Payment may be made by check (subject to check clearing), ACH electronic fund transfer, or wire transfer. Payment may be made by credit card only with prior written approval by an authorized Homeland Vinyl Products, Inc. (“Homeland”) representative – additional fees may apply. At Homeland’s request, Customer shall complete or update an Application for Trade Account signed by a corporate officer, managing member, partner, or owner. Customer agrees that prior to Homeland providing or extending credit terms, Homeland shall have the right to demand financial information, including financial data, credit checks, and payment history. Credit terms are subject to change at Homeland’s sole discretion. Homeland reserves the right to withhold shipment on any order for customer accounts that are in arrears until the accounts are paid in full. Customer agrees that accounts not paid within terms will be charged interest at the rate of 1.5% per month, and Customer agrees to pay all amounts due, including interest, fees, and costs of collection upon demand by Homeland. Prices are subject to change without notice.

PLACING ORDERS – All orders must be submitted in writing to Homeland, and must describe with specificity part numbers, color, detailed descriptions, and quantities. Illegible orders will not be accepted. All orders are subject to Homeland’s acceptance, approval, and these Terms and Conditions, whether or not these Terms and Conditions are included in Homeland’s written confirmation to Customer.

CANCELLATION – Following Homeland’s written confirmation of Customer’s order, Customer shall not be permitted to cancel, whether in whole or part, any order and shall be obligated to pay the entire invoice.

SHIPMENT – All prices are F.O.B. Homeland Vinyl Products Inc. Origin Freight Collect, unless otherwise set forth on the invoice or otherwise agreed upon in writing signed by an authorized Homeland representative. Products listed on the invoice (the “Products”) are invoiced at Homeland’s prices prevailing at time of shipment. Method, origin, and route of shipment are subject to Homeland’s sole discretion unless Customer and an authorized Homeland representative agree in writing to other explicit shipping instructions. Customer bears any and all shipping expenses and costs in excess of those charges explicitly acknowledged in writing by an authorized Homeland representative. Customer is exclusively responsible for providing Homeland a correct shipping address.

FORCE MAJEURE & DELAYS – Homeland is not and shall not be liable for any obligations, delays, or damages incurred by Customer under any purchase order, invoice, or other agreement between the parties if Homeland’s non-performance is or was due to a Force Majeure Event, as described here: any act of God; war; riot; civil strife; act of terrorism, domestic or foreign; embargo; government rule, regulation, or decree; flood, fire, hurricane, tornado, or other casualty; epidemic, pandemic, outbreak of communicable disease, viral outbreak, or quarantine; national or regional emergency; action of any governmental authority; earthquake; strike; lockout, or other labor disturbance; the unavailability of labor or materials to the extent beyond the control of Homeland; any delay in the performance of orders or in the delivery of shipments of products; or any other events or circumstances not within the reasonable control of Homeland, whether similar or dissimilar to any of the foregoing. Upon occurrence of a Force Majeure Event, Homeland shall promptly notify the Customer that such an event has occurred and its anticipated effect on performance, including its expected duration if known. Notwithstanding the foregoing, no Force Majeure Event experienced by Homeland shall excuse Customer’s obligation to make payments due and owing prior to such event.

TAXES – Any and all sales taxes, manufacturer taxes, excise taxes or other charges levied or imposed by any governmental authority, agency or entity, foreign or domestic, upon any Products sold or contracted to be sold shall be paid by Customer and appropriate tax exemption certificates must be delivered in such form to Homeland and with such content as are satisfactory to Homeland.

INSPECTION AND ACCEPTANCE – CUSTOMER SHALL CAREFULLY EXAMINE ALL PRODUCTS DESCRIBED IN THE INVOICE IMMEDIATELY UPON DELIVERY. CUSTOMER MUST PROVIDE HOMETLAND WITH WRITTEN NOTICE OF ANY ALLEGED DEFECTIVE PRODUCT WITHIN SIXTY (60) DAYS AFTER DELIVERY. CUSTOMER’S FAILURE TO NOTIFY HOMETLAND IN WRITING OF ANY DEFECTS IN THE PRODUCTS WITHIN SIXTY (60) DAYS AFTER DELIVERY CONSTITUTES THE UNQUALIFIED ACCEPTANCE OF SUCH PRODUCTS AND THE WAIVER BY CUSTOMER OF ANY AND ALL CLAIMS OR DEFENSES WITH RESPECT THERETO. Customer is exclusively responsible to unload all Products. Within forty-eight (48) hours of Customer’s receipt of each shipment, Customer shall inspect the shipment and compare all containers and Products to the packing list for the shipment. If the quantities received and the quantities on the packing list are not the same, Customer shall notify Homeland immediately. Within forty-eight (48) hours of Customer’s receipt of each shipment, Customer is responsible to inspect packaging materials and products for dents, tears, breakages, or other visible damage to packaging or products, and to note such matters on shipping documents provided to the freight carrier and Homeland. If Customer fails to notify Homeland within 48 hours after receipt of any such matters, Homeland shall no longer be responsible or liable for damaged items or items missing from the shipment.

CUSTOMER’S EXCLUSIVE REMEDY – The exclusive remedy of Customer shall be limited to any of the following: (1) the replacement of any defective Product by Homeland, (2) the return of any defective Product and refund of the purchase price by Homeland, or (3) the issuance of a credit by Homeland in an amount equal to the purchase price paid by Customer for any defective Product. The selection of any of the aforesaid exclusive remedies shall be at Homeland’s sole discretion. In the event Customer requests a credit for any defective Product, Customer agrees (1) such product shall no longer be covered by Homeland’s warranty, (2) Homeland expressly disclaims any warranty, written or implied, associated with such product, and (3) Customer shall defend and indemnify Homeland against any and all claims associated with such product that Customer thereafter delivers, distributes or sells to third parties.

LIMITED WARRANTY – Homeland warrants that the Products are free of defects in materials and workmanship as set forth in Homeland’s warranty located at www.homelandvinyl.com.

WARRANTY DISCLAIMERS – THE LIMITED WARRANTY AND EXCLUSIVE REMEDY DESCRIBED ABOVE ARE EXPRESSLY IN LIEU OF ANY OTHER REMEDIES AND WARRANTIES, EXPRESSED OR IMPLIED, ON THE PART OF HOMETLAND CONCERNING THE PRODUCTS. HOMETLAND DISCLAIMS, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. HOMETLAND DISCLAIMS ANY WARRANTIES NOT EXPRESSLY SET FORTH IN HOMETLAND’S WRITTEN WARRANTY SET FORTH AT www.homelandvinyl.com. HOMETLAND NEITHER ASSUMES NOR AUTHORIZES ANY OTHER PERSON, FIRM OR CORPORATION TO OBLIGATE HOMETLAND WITH RESPECT TO ANY LIABILITY OR OBLIGATIONS IN CONNECTION WITH THE SALE OF HOMETLAND PRODUCTS. CUSTOMER ACKNOWLEDGES THAT NO REPRESENTATION EXCEPT THOSE MADE HEREIN HAVE BEEN MADE TO CUSTOMER BY OR ON BEHALF OF HOMETLAND CONCERNING THE PRODUCTS AND THAT CUSTOMER HAS NOT AND WILL NOT RELY ON ANY OTHER REPRESENTATIONS REGARDING WARRANTIES OR QUALITY OF HOMETLAND PRODUCTS EXCEPT AS SET FORTH IN HOMETLAND’S WARRANTY SET FORTH AT www.homelandvinyl.com. CUSTOMER AND ANY THIRD PARTIES TO WHOM IT SELLS THE PRODUCTS ARE EXCLUSIVELY RESPONSIBLE FOR DETERMINING WHETHER THE PRODUCTS MEET APPLICABLE LAWS OR LOCAL BUILDING CODES AND WHETHER PRODUCTS ARE SUITABLE FOR THE INTENDED USES OF END-USERS, AND CUSTOMER AGREES HOMETLAND IS NOT RESPONSIBLE FOR DETERMINING SUITABILITY FOR INTENDED USES OR SATISFACTION OF APPLICABLE LAWS OR BUILDING CODES.

RISK OF LOSS – Unless otherwise specified herein, all prepaid expenses (e.g., freight, special handling charges such as after-hours loading, etc.) will be added to the order at time of invoicing and described on the invoice. RISK OF LOSS SHALL PASS TO CUSTOMER UPON DELIVERY OF THE PRODUCTS BY HOMETLAND TO THE CARRIER, AND CUSTOMER’S SOLE RECOURSE FOR DAMAGE TO OR LOSS OF GOODS IN TRANSIT SHALL BE AGAINST THE CARRIER. HOMETLAND WILL PROVIDE NO INSURANCE UNLESS CUSTOMER HAS MADE SPECIFIC ARRANGEMENTS PRIOR TO SHIPMENT AND HOMETLAND HAS CONFIRMED SUCH ARRANGEMENTS IN WRITING.

RETURNED MERCHANDISE – All returns of Products for credit must have the prior written approval of an authorized Homeland representative and must be for justifiable reasons. Any credit extended for such approved returns will be based on the invoice price of the returned Products at time of purchase by Customer less a restocking charge of 20%. No Products shall be returned for credit which have been damaged or otherwise rendered unusable, unless otherwise approved in writing by an authorized Homeland representative. Custom and special order items will not be accepted for return. All returned Products shall be returned freight prepaid by Customer with Customer assuming the risk of loss until Homeland receives the Products.

ADDITIONAL LIMITATIONS ON LIABILITY – The invoice, including these Terms and Conditions, sets forth the sole and exclusive remedies available to the Customer and that Homeland’s liabilities to Customer are limited as set forth herein. Homeland has not granted or assumed any other warranties, guarantees, duties, liabilities, or obligations, expressed, implied, statutory, at law or in equity. No breach of warranty or breach of contract or other failure by Homeland to fulfill any other duties or conditions shall constitute a failure of the essential purpose of the exclusive limited remedies set forth herein. HOMETLAND SHALL UNDER NO CIRCUMSTANCES BE LIABLE FOR SPECIAL, INCIDENTAL, EXEMPLARY, PUNITIVE, INDIRECT, OR CONSEQUENTIAL DAMAGES, including, but not limited to, any damages related or attributable to loss of profits, anticipated revenue, interest, loss of use, loss by reason of plant or facility shutdown, nonoperation, cost of substitute products, equipment, facilities or services, additional usage of utilities, cost incurred in removing defective or nonconforming Products or equipment, delays in installation of the work or the completion of any projects in which equipment is being installed, or other claims arising from any cause whatsoever, whether or not such loss or damage is based in contract, warranty, tort (including negligence), strict liability, indemnity, contribution or otherwise. Customer agrees Homeland shall have no liability whatsoever unless Customer makes payment in full to Homeland for the Products.

DISPUTES – In the event of Customer’s failure to pay amounts due under any invoice, and if Customer has failed to notify Homeland of defective product claims pursuant to the procedures set forth in these Terms and Conditions, Customer agrees to waive any defenses to Homeland’s demands and claims for payment. These Terms and Conditions shall be governed by the laws of the State of Utah (without regard to the conflicts of law provisions thereof). Customer hereto consents to the jurisdiction of the state and federal courts located in Salt Lake County, Utah as the exclusive jurisdiction of the resolution of any claims or disputes related hereto. CUSTOMER WAIVES ANY RIGHT TO A TRIAL BY JURY IN ANY JURISDICTION.

SEVERABILITY – In the event that a court of competent jurisdiction determines that a provision or provisions of the invoice, including these Terms and Conditions, is (are) void or unenforceable, such determination shall in no way affect the validity of enforceability of the remaining provisions hereof.

ENTIRE AGREEMENT – These Terms and Conditions, together with any invoice from Homeland, set forth the entire agreement between Homeland and Customer concerning the Products, and may not be changed or modified except in a writing signed by Homeland and Customer. No representations, understandings, or agreements have been made to or relied upon by Customer other than those specifically set forth in the invoice. Customer agrees that Homeland’s Terms and Conditions apply exclusively to the parties’ commercial relationship, unless otherwise agreed upon in a writing signed by Customer and an authorized Homeland representative. By purchasing Homeland’s Products, Customer agrees that any and all terms, conditions or other contractual provisions provided in any writing or communication sent by Customer are null, void, unenforceable, and of no legal effect upon Homeland.
